MINUTES OF TRIAL:

Discussion held in chambers.

Exhibit #190-5X7 Manila Evidence Envelope is pre-marked for identification purposes as requested by Defense counsel Coleman.

Court convened at 9:15 a.m., Jury, Alternates, the People represented by Deputy District Attorney Robert Shane Burns and Larry Crouch, the Defendant, David Martin Hawk, represented by Attorney Mark Coleman and Co-counsel Dennis Peterson and court staff present. Witness, Chelsa Hawk retakes the witness stand and resumes with testimony. Pre-marked Exhibits #185 and #186 are now identified for the record. Witness is excused. Witness, Conrad Hawk is sworn and testified as requested by the People. Jury and Alternates are admonished and Court recessed for short break.

Court reconvened at 10:44 a.m., Jury, Alternates, all parties and court staff are present. Witness, Conrad Hawk retakes the witness stand and resumes with testimony. Jury and Alternates admonished and Court recessed for lunch break. All parties ordered back at 1:30 p.m.

Court reconvened at 1:33 p.m., Jury, Alternates, all parties and court staff are present. Witness, Conrad Hawk retakes the witness stand and resumes with testimony. Exhibit #191-8X10 Colored Photograph of defendant's bedroom, Exhibit #192-8X10 Colored Photograph of defendant's formal living room and Exhibit #193-8X10 Colored Photograph of defendant's second living room are marked for identification purposes as requested by the People. People request that Exhibits #191, #192 and #193 be admitted into evidence. No objection by Defense Counsel. Court deems Exhibits #191, #192 and #193 be admitted into evidence as requested by the People. Pre-marked Exhibit #190 now identified for the record. Defense counsel cuts open Exhibit #190 and removes a white mailing envelope. Exhibit #190a-White mailing envelope with the writing "Dave" on it as contained within Exhibit #190 is marked for identification purposes as requested by Defense counsel Peterson. Jury and Alternates are admonished and recessed for short break.

Court reconvened at 3:22 p.m., outside the presence of the Jury and Alternates. All parties and court staff are present. People present arguments regarding Defense counsels' request to introduction of evidence with regards to comments made by Conrad Hawk to the Defendant, David Hawk. Defense counsel Peterson presents argument. Court sustains the objections made.

Court reconvened at 3:28 p.m., Jury, Alternates, all parties and court staff are present. Witness, Conrad Hawk retakes the witness stand and resumes with testimony. Jury and Alternates are admonished and Court recessed until Monday, August 17, 2009 at 9:00 a.m.
