Our last hearing was 11/15/2023, Jesse did not attend. The court made orders that Jesse's son, Zackariah, was not to be within 100 yards of our 2 minor daughters.

On 11/26/2023 I had a friend of mine serve Jesse with the order saying that Zackariah had to stay 100 yards away from our children. I was waiting at the Circle K while Jesse was being served by my friend. My friend picked me back up at the Circle K. My friend said when he was leaving he could hear Jesse screaming when he went back inside the house. (Jesse was served at his grandmothers house. Our kids were there at the time)

Jesse's aunt contacted me on 12/03/2023 and told me that Jesse's son Zackariah had died on 11/30/2023. She told me he had abdominal pain, got medicine from the hospital, went home and then was dead. I was told by Jesse's cousin that the EMT had mentioned something about "blunt force trauma" to Zackariah's abdomen. Jesse's other cousin said someone had mentioned something about "air" in Zackariah's veins.

Jesse has not contacted me or notified me of anything since this happened. The last time I had communication with Jesse was on 11/22/2023. On 12/03/23 Jesse was supposed to have a visit with our children.


