1 Our last hearing was 11/15/2023, Jesse did not attend. The court  
2 made orders that Jesse's son, Zackariah, was not to be within 100  
3 yards of our 2 minor daughters.

4  
5 On 11/26/2023 I had a friend of mine serve Jesse with the order  
6 saying that Zackariah had to stay 100 yards away from our children.  
7 I was waiting at the Circle K while Jesse was being served by my  
8 friend. My friend picked me back up at the Circle K. My friend said  
9 when he was leaving he could hear Jesse screaming when he went back  
10 inside the house. (Jesse was served at his grandmothers house. Our  
11 kids were there at the time)

12  
13 Jesse's aunt contacted me on 12/03/2023 and told me that Jesse's  
14 son Zackariah had died on 11/30/2023. She told me he had abdominal  
15 pain, got medicine from the hospital, went home and then was dead.  
16 I was told by Jesse's cousin that the EMT had mentioned something  
17 about "blunt force trauma" to Zackariah's abdomen. Jesse's other  
18 cousin said someone had mentioned something about "air" in  
19 Zackariah's veins.

20  
21 Jesse has not contacted me or notified me of anything since this  
22 happened. The last time I had communication with Jesse was on  
23 11/22/2023. On 12/03/23 Jesse was supposed to have a visit with our  
24 children.

1 The kids and I had been waiting in front of the Police Station for  
 2 30 minutes so I began messaging Jesse to see where he was at and if  
 3 he was going to show up.

4 Jesse never showed up. (No show case #2312030044) Later that day I  
 5 messaged Jesse my condolences about Zackariah. Jesse didn't view  
 6 any of those messages until 12/07/2023.

7  
 8 I have attached a print out of a social media posting by Jesse and  
 9 his wife Tabitha where they acknowledge there will be a  
 10 "celebration of life".

11  
 12 I am very concerned for the safety of our children. It is very  
 13 suspicious to me that 4 days after I served Jesse the court order  
 14 saying Zackariah had to stay away from our children he ends up  
 15 dead.

16  
 17 I don't feel it's safe for our children to have any visitations  
 18 with Jesse at this time. Since 11/27/2023 our youngest child has  
 19 started wetting the bed and having night terrors. The therapist  
 20 believes it's triggered by childhood trauma. This has been  
 21 happening since visitations started back up with dad. Our older  
 22 daughter said she can't tell me what she does at her dad's house  
 23 because he says it's a "secret". I told her we don't keep secrets.
