- 18 ■ The document must be two-holed punched at the top
- 19 ■ Paper must be 8.5 x 11 inches
- 20 ■ Margins should be one inch
- 21 ■ Body is double-spaced
- 22 ■ Quotes and Property Descriptions can be single spaced
- 23 ■ Use 12 point typeface
- 24 ■ Only use one side of the paper
- 25 ■ Number each page at the bottom of the page
- 26 ■ The title of the pleading must be at the bottom of each page
- 27 ■ All pages must be stapled
- 28 ■ If you are representing yourself, you must list yourself as "In Pro Per"
- Utilize the spacing and format demonstrated above for all first pages of your pleading
- Indent each paragraph five [5] spaces
